At the end of this period, if we have not received your booking form with the deposit, the option will automatically be cancelled.</p> <p><input type="checkbox"/> RESERVATION : The reservation is nominative and can not be transferred to another person. Upon receipt of your completed form, accompanied by the deposit (180 €) and reservation fee (40 € non-refundable) paid by credit-card or bank transfer, you will receive written confirmation, with an allocated pitch number.</p> | <p><input type="checkbox"/> Your stay in high season from 11/07 to 22/08/2021 is weekly and the reservation of your pitch is from Sunday to Sunday. CONDITIONS OF CONTRACT

1 - The number of the hired pitch is determined when you receive the receipt for your deposit payment which also confirms the acceptance of the dates thus rendering a definite contract of hire.

2 - Cancellation insurance : We recommend you to subscribe a cancellation insurance.

-the cost amounts to 20 € per stay and should cover the total number of days of the booked period. The insurance can only be taken out when the initial reservation is made. The amount due for the insurance should be paid together with the initial down payment. -the insurance will only pay out your deposit minus the reservation fee (40€) and cancellation insurance (20€) if you notify the campsite of the cancellation by registered mail together with the relevant (official) statements and/or documents within 3 days after the event giving rise to the cancellation.

-the insurance will only pay out if notification is given between the date of reservation and the first day of the booked period. -the following items are covered : *death, a serious accident with bodily harm, a serious sickness of yourself or next of kin. *dismissal by the employer of yourself or your spouse. *a move as a result of a transfer within the organisation that employs you. *damage to your house as a result of fire, breaking and entering, vandalism, bad weather conditions or natural disasters.

-the insurance will only pay out if one of the above events happens before your stay and not during your stay.

3 - The hirer is required to take possession of his booked pitch by the date as stated overleaf. The contract will be void if occupation is not made after 24 hours from commencement of the booked period. Thereafter the contract

is deemed to be cancelled. In this case, the deposit paid is not returnable and full letting rights of the concerned pitch revert to the owner. Esterel Caravaning will be in the position to rent the pitch immediately.

A deposit is required on arrival for the 'Imperial', 'Deluxe Prestige', 'Luxe', 'Palace de luxe' & 'Confort' pitches. This deposit will be returned on departure, after reception of the key and after the departure 'check-out' for pitch/equipment cleanliness.

The pitch rentals with Jacuzzi (Palace de Luxe, Royal Maxi & Imperial) must be rented for 4 nights minimum.

4 - If on arrival the hirer wishes to change the allocated pitch for another, this can only be done depending on availability and with consultation of the management.

5 - The pitch amenities consist of an electrical point of 16 A to 32 A, water, drainage and of course, communal shower and toilet blocks. The Luxe, Palace de Luxe, Imperial and Deluxe Prestige pitches have private toilet, wash basin and shower facilities with hot water, electrical point, a waste water outlet and heating.

6 - The prices are set at the beginning of the season and include water, electricity, swimming pools, free games and activities, except for mountainbike rental.

7 - During the high season, the hiring period for the touring pitches is from Sunday to Sunday. The price for 2 people is per week. You will be billed for the booked dates and you need to pay your stay upon arrival.

8 - BARBECUES AND ANY OTHER FORM OF OUTDOOR COOKING WITH FLAMES ARE STRICTLY FORBIDDEN.

9 - Maximum of 6 persons per pitch : For safety and comfort reasons, the number of persons per pitch is limited to 6. Pets are permitted , please notify us if you wish to bring an animal. Dogs should be permanently held on a leash and droppings need to be collected.

10 - The hirer and his family must respect and abide by the campsite rules noted in the information book given at arrival and on the notice board outside reception.

11 - The WIFI is free but Esterel Caravaning cannot be held responsible for the network or the connection rate.

12 - Board shorts and shorts are strictly forbidden in the swimming pool.

13- MEDIATOR : In case of a dispute and after contacting the company's «customer» services department, any campsite customer has the ability to contact a consumption mediator, within a period of one year from the date of the written complaint, by recorded delivery, to the owner. MOBILE HOME RENTAL

1-When to book ? Reservations for mobile homes are taken from November. You can also book on line on the website www.esterel-caravaning.co.uk

The office is closed during the school holidays at Christmas.

2-How to make a reservation ? Reservations are accepted by post, telephone, e-mail. Requests by telephone need to be followed up in writing within 72 hours. The booking form, with all details completed, needs to be returned to the address indicated on the form. The following needs to be paid when the reservation is made : a down payment of 40 % of the rental cost and if desired, the amount due for the cancellation insurance. A non-refundable amount of 40 € to cover administrative reservation costs.

3-Payment in full : The booking will only be definite once the remaining amount is transferred to us, 6 weeks before the arrival date. Should your booking be made 6 weeks or less before the booked period, the total amount should be transferred. Payment may be done either by credit card or bank transfer. Regretfully, payment by international money-order cannot be accepted. In the absence of any explanation with regard to non-payment of the full amount, your reservation will automatically be cancelled. The reservation fee is offered for all stay in April, May, June and September.

4-Booking modification: Bookings can be updated up to 6 months before arrival, within the limits of availabilities.

5-Cancellation : If the reserved accommodation is cancelled at least 6 weeks before the intended period, the down payment of 40% of the rental cost + €40 booking fee will not be refunded. If the reserved accommodation is cancelled less than 6 weeks before the intended period, the total of the rental cost will not be refunded. Late arrival or early departure will not result in any refunding of part of the rental cost.

6-Cancellation insurance: We recommend you to subscribe a cancellation insurance.

-the cost amounts to 20 € per stay (non refundable) and should cover the total number of days of the booked period. The insurance can only be taken out when the initial reservation is made. The amount due for the insurance should be paid together with the initial down payment. -the insurance will only pay out if you notify Esterel Caravaning of the cancellation by registered mail together with the relevant (official) statements and/or documents within 3 days after the event giving rise to the cancellation.

-the insurance will only pay out if notification is given between the date of reservation and the first day of the booked period. -the following items are covered : *death, a serious accident with bodily harm, a serious sickness of yourself or next of kin. *dismissal by the employer of yourself or your spouse. *a move as a result of a transfer within the organisation that employs you. *damage to your house as a result of fire, breaking and entering, vandalism, bad weather conditions or natural disasters.

-the insurance will only pay out if one of the above events happens before your stay and not during your stay.

7-Your stay: From 07/10 to 08/28, the mobile homes are at your disposal from Saturday 5 pm until Saturday 10 am. Outside these periods, arrival and departure may take place on any day of the week provided that the minimum stay

is 2 or 4 nights (depending on the category). In such case, the rental costs will be calculated per night. Every tenant is obliged to take note of and abide by the site rules of Esterel Caravaning. Whom cannot be held liable for loss or theft of personal belongings, personal injuries or damages occurring during your stay. A deposit of 200€ will be requested upon arrival for the rent of a mobile home. Before leaving, you must clean the mobile home and defrost the fridge. Otherwise, you will be charged for an end-of-stay cleaning.

8-Unoccupied mobile home: In absence of a written confirmation of the hirer saying that he wants to change his arrival date, the mobile home will become available for hiring 24 hours after the arrival-date mentioned on the original contract.

9-Pets: Pets are welcome (2 maximum). Please notify us if you wish to bring an animal. Dogs should be permanently held on a leash.

10-Occupancy : For administrative reasons and for your comfort, the maximum number of people, depending on the category, must be respected. Any additional persons to the maximum allowed for each type of mobile home will be refused. A baby counts for a person.

11 - The WIFI is free but Esterel Caravaning cannot be held responsible for the network or the connection rate.

12-Parking: One car per mobile home. €5 per day will be charged for any additional vehicle. Only if the size of the place allows this.

13-Board shorts and shorts are strictly forbidden in the swimming pool.

14-MEDIATOR: In case of a dispute and after contacting the company's «customer» service, any campsite customer has the ability to contact a consumption ombudsman, within a period of one year from the date of the written complaint, by registered letter, to the owner. 15-TAX AND SITE FEE : A tourist tax and a site fee are due, the amount needs to be paid in full upon arrival :

*The tax (subject to change) per day amounts to €0.66 per person from 18 years of age.

*The charge of €3 per person per day is required by Esterel Caravaning (offered for baby under 1 year of age) to cover utility costs and your use of the site facilities - Eco tax of €0.40 € included -

This site fee includes water, electricity and gives you the access to all the activities and services on the site. A €200 security deposit per mobile home must be paid on arrival. Before your departure, you have to clean the mobile home and defrost the fridge, otherwise and end-of-stay cleaning fee will be charged.
